#### **EXECUTIVE ORDER NO. 09** 35 BARANGAY'S OF

Series of 2024

### AN ORDER RECONSTITUTING AND STRENGTHENING THE MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN OF THE MUNICIPALITY OF KITAOTAO, BUKIDNON.

WHEREAS, the United Nations Convention on the Human Rights of the Child the vulnerability of children and their need for legal and other protective mechanisms before and after birth, and the vital role of international cooperation is securing child's rights;

WHEREAS, Republic Act 7160 is a landmark legislation that seeks to protect children against all forms of abuse, exploitation, discrimination and other conditions prejudicial to the development;

WHEREAS, Philippine Constitution guarantees the rights of women and children;

WHEREAS, Article 359 and 360 of the Civil Code of the Philippines provides that the "government establish Councils for the Protection of Children;

WHEREAS, Article 87 of Presidential Decree (Child and Youth Welfare Code) states that "every barangay council shall encourage the organization of a Local Council for the Protection of Children (LCPC) that will draw up and implement programs for child and youth welfare". There is therefore, a need to reorganize LCPC not only in the barangays but in the municipality, to ensure synchronization and integration of policies, programs and projects for children;

WHEREAS, the Municipal Government of Kitaotao is committed to uphold women and children's rights and protection and shall pursue program and mechanisms to ensure the protection and development of children as mandated by the Constitutions and other existing laws;

NOW, THEREFORE, I, EDWIN P. ABUCAYAN, Municipal Mayor, Municipality of Kitaotao, Province of Bukidnon, by virtue of the power vested in me by law as Municipal Mayor, do hereby order the reorganization and strengthening of the Municipal Council for the Protection of Children.

## SECTION 1. COMPOSITION OF THE MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN.

# SECTION 2. FUNCTIONS OF THE MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN.

- Formulate, develop, coordinate, monitor and review all local policies (to include BCPC prepared and issued policies), ordinances, plans, programs, and activities which shall promote the best interest and rights of children and ensure mainstreaming in the local development agenda;
- 2. Prepare Annual Work and Financial Plan (AWFP LCPC WFP Form 001-B) consistent with its functions as provided herein and in the local EO creating it;
- 3. Establish, maintain and update a disaggregated database or local information system on all children within the city/municipality and shall include the information gathered by the BCPC identified in item;
- Conduct advocacy activities on the promotion and protection of the rights and welfare of children including the development of information, education, and advocacy materials;
- 5. Conduct capability-building activities for all stakeholders on children including in the barangay level;
- 6. Provide assistance to children in need of special protection;
- 7. Document good practice/s on children;
- 8. Coordinate and consult with other LCPCs, LGUs and other regional and national authorities with respect to policies and PPAs on children;
- 9. Organize the necessary documents needed by the concerned IMTF as identified in item 4.6.4.2; and
- 10. Conduct the Child-Friendly Local Governance Audit (CFLGA), through the LCPC Inter-Agency Monitoring Task Force (IMTF), annually;

# SECTION 4. FUNCTIONS OF THE MUNICIPAL TECHNICAL WORKING GROUP (MTWG)

The Municipal Technical Working Group shall the following functions:

- 1. Prepare Municipal Development Plan for the Protection and Welfare of Women and
- 2. Implement programs, projects and activities base on the approved work and financial
- 3. Monitor and evaluate programs, projects and activities related to women and childfriendly environment;
- 4. Prepare and submit quarterly reports on programs, projects and activities implemented;
- 5. Provide technical and administrative support to the Municipal Council for the Protection of Women and Children:
- 6. Advocate for the passage of child-friendly resolutions and ordinances;
- 7. Ensure proper coordination among national and local government agencies, nongovernment organizations, people organization and the civil society in the implementation of CPC Programs, projects and activities;
- 8. Perform such other functions as may be directed by the Council.

# SECTION 6. FUNCTIONS OF THE MUNICIPAL - IMTF

b. Advocate for support and assistance for the promotion and realization of children's rights based on the results of the CFLGA.

**SECTION 9. FUNCTIONS AND RESPONSIBILITIES OF THE SECTORAL COMMITTEES.** The sectoral committee shall perform the following:

1. Define sectoral or functional objectives, set targets and identify programs, programs and activities for the particular sector or function;

2. Provide the MCPC with data and information essential to the formulation of plans, programs and activities pertaining to their particular sector;

3. Collate and analyze information and statistics and conduct related studies

- 4. Conduct public hearing on vital issues affecting the sector or functions;
- 5. Coordinate planning, programming and implementation or programs, projects, activities within each sector;
- 6. Monitor and evaluate programs and projects, and
- 7. Perform such other functions may be assigned by the MCPC.

### SECTION 10. BUDGETARY APPROPRIATION

There is hereby appropriated an annual budget for the operationalization of the programs, projects and activities for the children.

### **SECTION 11. MONITORING AND EVALUATION**

To determine the functionality of the MCPC and look into their accomplishment, including implementation problems and issues, regular monitoring shall be conducted using the prescribed form as mandated.

### **SECTION 12. MEETING.**

The MCPC shall meet every 2<sup>nd</sup> Friday of the 1<sup>st</sup> month of every quarter and as often as necessary. The majority of the members shall constitute a quorum, but the Chairman and Vice Chairman must be present during the meetings where budgetary proposals are being prepared or considered. The affirmative vote of a majority of the members shall be necessary to approve such proposals.

In the absence of the Chairman and Vice Chairman, the members present constituting a quorum shall elect among themselves who may preside for such meeting only, which does not involve consideration of budgetary proposal.

The sectoral committees shall meet as often as necessary.

### **SECTION 13. REPEALING CLAUSE**

All prior issuances on the reorganization and function of the MCPC and TWG which are inconsistent herewith shall be deemed superseded by this order.

### **SECTION 14. EFFECTIVITY**

This Executive Order shall take effect immediately.
