AN ORDER RECONSTITUTING THE INFORMATION AND SERVICE DELIVERY NETWORK (ISDN) IN THE MUNICIPALITY OF KITAOTAO, BUKIDNON, DEFINING THE ROLES AND FUNCTIONS OF ITS MEMBERS, PROVIDING FUNDS THEREOF, AND FOR OTHER PURPOSES.

WHEREAS, Republic Act No. 10354 also known as "The Responsible Parenthood and Reproductive Health Act of 2012" lays out the role of Local Government Units in the integration of responsible parenthood and reproductive health care services through Service Delivery Networks for Reproductive Health Care.

WHEREAS, the current Socio-Economic Agenda includes the Strengthened implementation of the Responsible Parenthood and Reproductive Health Law to enable especially poor couples to make informed choices on financial and family planning, and directs the creation of an Information and Services Delivery Network (ISDN) as an important strategy to address issues and concerns of the Adolescent Reproductive Health and Development.

WHEREAS, Administrative Order No. 34-A, s. 2000 of the Department of Health provides the Adolescent and Youth Health Policy which aims to ensure that all adolescent and youth have access to quality comprehensive health care and services in an adolescent & youth-friendly environment.

WHEREAS, Administrative Order No. 2013-0013, of the Department of Health provides the National Policy and Strategic Framework on Adolescent Health and Development which aims to provide a strategic framework for the Adolescent Health Program that is anchored on Universal Health Care.

WHEREAS, the Young Adult Fertility Study (YAFS 4) conducted by the University of the Philippines Population Institute (UPPI) revealed that teenage pregnancy in Northern Mindanao has considerably increased from 4.6% in 2002 to 14.7% in 2017 (NDHS, 2017). To address the issue of teenage pregnancy and other emerging issues on health risky behaviors among adolescents, a multi-sectoral and collaborative approach among stakeholders must be made to effectively and efficiently share resources and respond to adolescents concerns especially in their access to reproductive health information and other development services.

NOW THEREFORE, I, Edwin P. Abucayan, Municipal Mayor of Kitaotao, Bukidnon, by virtue of the powers vested in me by Constitution and other pertinent laws, do hereby

order the reconstitution of the Information and Services Delivery Network (ISDN) of this municipality.

Section 1. Creation and Composition of the Information and Service Delivery Network (ISDN) The Information Service and Delivery Network, herein referred to as ISDN, shall be a network of stakeholders from the government, non-government, academe, and youth-led organizations providing reproductive health information and development services for the health, wellness and other development needs of adolescent and young people at the municipal level. The ISDN is now hereby reconstituted and shall generally compose of the following:

Section 2. Tasks and Functions

The Municipal ISDN shall serve primarily as a technical advisory to the Local Chief Executive (LCE) to ensure that information and services on health and development

needs will be adequately provided to the adolescents and youths in the municipal. Specially, the ISDN have the following task and functions:

2.1 Convene and mobilize to collectively operationalize the ISDN including the:

- a. Identification of the critical health and development issues among adolescents in the locality;
- b. Mapping of available adolescent friendly facilities, institutions and services;
- c. Providing relevant information and services on health and development;
- d. Monitoring and evaluation of ISDN initiatives.

2.2 Coordinate/Harmonize plan of action in areas of policy development, capacity building, advocacy, education, information, dissemination, health and development service delivery, field operations monitoring and evaluation and other related roles and functions within the context and framework of ISDN.

2.3 Establish and maintain a functional collaborative and referral mechanism to ensure availability of information and services for adolescent health concerns within the ISDN area of Responsibility.

2.4 Develop, plan, coordinate and conduct joint and collaborative projects and programs on Adolescent health and development.

2.5 Generate and share resources for the sustainability of ISDN collaborative strategies.

2.6 Resolve emerging implementation concerns and provide recommendation to improve the implementation and impact of the ISDN in the municipal level.

2.7 Establish and undertake periodic monitoring and evaluation activities for the enhancement of ISDN strategies and provide regular reports to POPCOM Provincial Population Office.

2.8 Take action on any additional tasks, roles and functions as maybe deemed necessary based on the identified issues and its corresponding interventions by Agency members to effectively implementing the ISDN strategies.

Section 3. Budget Integration of all concerned Departments.

All departments concerned are hereby ordered to align their programs, projects and activities to ensure that ISDN dimensions are integrated into their plans with reference to the mandate and framework of the RPHP Law (RA 10354).

Section 4. Funding Source
