## **EXECUTIVE ORDER NO. 12**

Series of 2024

AN ORDER REORGANIZING THE MUNICIPAL IMPLEMENTATION TEAM (MIT) FOR RA 10354 OR THE RESPONSIBLE PARENTHOOD AND REPRODUCTIVE HEALTH ACT, DEFINING THE ROLES AND FUNCTION OF ITS MEMBERS, PROVIDING FUNDS THEREOF, AND FOR OTHER PURPOSES.

WHEREAS, the passage of RA 10354 or the Responsible Parenthood and Reproductive Health Act and the eventual declaration of the Supreme Court of its constitutionality signals a new dawn on the effort to deliver Responsible Parenthood and Reproductive Health Services to the vulnerable sector of our society, specifically the women;

WHEREAS, in giving a platform from which the intent and spirit of RA 10354, Executive Order No. 12 entitled: "Attaining and Sustaining Zero Unmet Need for Modern Family Planning Through the Strict Implementation of the Responsible Parenthood and Reproductive Health Act, Providing Funds Therefore, And for Other Purposes" was issued putting to task all relevant agencies of the government, the Department of Interior and Local Government and the Local Government Units among others, to do their respective shares in bringing about the services as envisioned by the law.

NOW THEREFOR, I, EDWIN P. ABUCAYAN, by virtue of the powers vested upon me, do hereby order to reorganize the Municipal Implementation Team (MIT) for RA 10354 or the Responsible Parenthood and Reproductive Health Act, Defining roles and function of the its members, providing funds therefor, and for other purposes.

### SECTION II. DUTIES AND FUNCTIONS:

The Municipal Implementation Team shall have the following tasks and functions:

- Disseminate and implement all issuances pursuant to RPRH Law and its IRR and all other issuances as issued by pertinent government agencies that have for its purpose the implementation of RA 10354;
- Coordinate the actions of the departments, sections and units within the Local Government Unit and of the national agencies implementing the law in the areas of policy development, capacity building, advocacy, education, information, health service delivery, field operations and monitoring and evaluation;
- Monitor the implementation and evaluate the impact of the RPRH Law, and in the area of Family Planning, ensure that the principle along Informed Choice and Voluntarism is strictly adhered to;
- 4. Prepare and submit regular reports as required, to the Provincial Implementation Team;

Do such other tasks and functions as may be assigned in accordance to existing law.

# III. FUNDING SOURCE:

Funding for the RPRH Law implementation shall be charged under the 5% GAD Fund of the Municipality.

## IV. EFFECTIVITY:

This Executive Order shall take effect immediately and shall remain valid until revoked, amended, or repealed by subsequent issuance.
